Admissions Guide for the International Class in Dayuan International Senior High School

> APPLICATION REQUIREMENTS

Parents of applicants who seek admissions to the International Class in Dayuan International Senior High School should meet **ONE** of the following qualifications:

- 1. A "foreign professional" engaging in professional work in the State. "Professional work," as stipulated in Article 46 of *Employment Service Act*, is limited to the following:
 - (1) Specialized or technical work.
 - (2) <u>Director/manager/executive of a business invested in or set up by overseas Chinese or foreigner(s)</u> with the authorization of the Government of the Republic of China.
 - (3) <u>Teacher</u> at the following schools:
 - i. Teacher at a public or registered private college/university or school established especially for foreign residents.
 - ii. Approved teacher teaching course(s) on foreign language(s) at a public or registered private primary or high school.
 - iii. Teacher teaching course(s) at a public or registered private experimental high school's bilingual department or at bilingual school(s).
 - (4) Sports coach and athlete.
 - (5) <u>Religious, artistic, and show business work</u>.
- 2. A "foreign special professional" possessing special expertise needed by the State in science & technology, the economy, education, culture, the arts, sports and other fields, as announced by the relevant central competent authority.
- 3. A "foreign senior professional" needed by the State as prescribed in Article 25 Paragraph 3 Subparagraph 2 of the *Immigration Act*.
- 4. A foreign professional employed in enterprises registered in Taoyuan city.

5. "Outstanding overseas scientific and technological personnel" recruited in pursuant to the relevant provisions of central government agencies or Academia Sinica to conduct research, give instruction, or provide other science and technology services and whose specialties and service scope are within the scope acknowledged by the <u>Ministry of Education ("MOE")</u>, <u>National Science Council</u>, and relevant agencies, as stipulated in *Regulations for Studying in Taiwan for Children of Outstanding Overseas Scientific and Technological Personnel*.

- 2. Application Documents (All shall be required.)
 - (1) Application form (please download the application form here: <u>http://www.dysh.tyc.edu.tw/home?cid=4833</u>);
 - (2) Two passport photos (with one attached to the application form);
 - (3) A copy of ID card or passport of the applicant's parent or guardian;
 - (4) A copy of birth certificate, kindship notarization, or any official documents that show the relationship with the applicant;
 - (5) A copy of employment certificate of the parent or guardian (<u>ONE</u> of the following):
 - i. Employment Gold Card;
 - ii. Certificate of employment AND Labor Insurance Card with the official seal of the company or

the relevant agency.

- iii. <u>Official documents issued by MOE</u> (for "Outstanding overseas scientific and technological personnel").
- (6) Official school transcripts in English for the last 2 years AND Certificate of Status Letter.
- (7) Either ARC of Working Visa of the applicant's parent or guardian.
- 3. Admission Interviews
 - (1) Parent interview will be conducted in either <u>Chinese</u> or <u>English</u>. Parents are expected to have a comprehensive understanding and recognition of the International Baccalaureate (IB) program, as well as demonstrate a strong willingness to support and cooperate with the school. Parents that do not approve of the educational philosophy of IB may result in rejection of admission.
 - (2) Applicant interview (15 minutes or more) will be held to identify the applicant's motivation, English proficiency, passion and academic potentials, which are to be evaluated based on the IB learner profile. <u>Applicants with a score lower than 70 will not be accepted.</u>
- 4. Enrollment
 - Candidates should bring along the originals of their recent academic background certificate. (No late enrollment will be accepted after the due time.)
 - (2) Date & Time: July 24, 2020 (Friday) 09:00-11:00
 - (3) Venue: Dayuan International Senior High School

NOTE:

- 1. The originals of the above-mentioned certificates should be verified by DYISH in advance of registration.
- 2. Any inaccurate, incomplete or false information given or any omission of information required shall render this application invalid and DYISH may at its discretion withdraw any offer of acceptance made on the basis of such information or, if already admitted, the applicant may be liable to disciplinary action, which may result in the expulsion from DYISH.
- 3. Acceptance of the application form and documents does not put the school under any obligation to take the admission.
- 4. Decision to admit or reject an application is at the sole discretion of the school authorities and is not open to dispute.
